In accordance with the Certification and Agreement for institutions applying for HEERF funds and to comply with Section 18004(e) of the CARES Act, Acupuncture and Massage College's 45-Day Report is posting on July 7, 2020 the information listed below on the institution's primary website – www.amcollege.edu. Accordingly, the following information has been easily made public and will be updated every 45 days thereafter in accordance with Section 18004(a)(1):

1. An acknowledgement that the institution signed and returned to the Department the Certification and Agreement and the assurance that the institution has used, or intends to use, no less than 50 percent of the funds received under Section 18004(a)(1) of the CARES Act to provide Emergency Financial Aid Grants to students.

Acupuncture & Massage College (AMC) acknowledges it signed and returned to the U.S. Department of Education the Certification and Agreement on 04/23/2020, and gives the assurance that AMC intends to use 50% of the funds received under section 18004(a)(1) of the CARES Act to provide Emergency Financial Aid Grants to students.

2. The total amount of funds that the institution will receive or has received from the Department pursuant to the institution's Certification and Agreement [for] Emergency Financial Aid Grants to Students.

The total amount of funds AMC received from the U.S. Department of Education for distribution to students is \$141,551.00.

3. The total amount of Emergency Financial Aid Grants distributed to students under Section 18004(a)(1) of the CARES Act as of the date of submission (i.e., as of the 30-day Report and every 45 days thereafter).

As of this 11/18/2020 Report, AMC has distributed \$141,552.90 to students.

As of the date of this Disclosure 11/18/2020, the total number of students that have received an Emergency Financial Aid Grant to students under Section 18004(a)(1) of the CARES Act is 144 in the 1st round and 98 in the 2nd round.

6. The method(s) used by the institution to determine which students receive Emergency Financial Aid Grants and how much they would receive under Section 18004(a)(1) of the CARES Act.

The method used for the 1st round of funds awarded: The College awarded a fixed grant amount to all qualified students that submitted an application.

The method used for the 2nd round of funds awarded: The College awarded the 2nd round of funds to all applicants that met the eligibility requirements and submitted an application demonstrating need before the designated deadline.
